Appendix:

- 1.  - 2) Any supplier shall provide the recipient of the mixture with a safety data sheet for free where a preparation does not meet the criteria for classification as dangerous in accordance with Directive 1999/45/EC, but contains any substance that is included in the Candidate List in an individual concentration of ≥ 0.1 % by weight for non-gaseous mixtures or ≥ 0.2 % by volume for gaseous mixtures.




